IT network audit project for a public institution in Paris. The site had not been in operation for several years, and most of the equipment had become obsolete, so a network audit was necessary.

Rack audit // Switch audit (IP, Vlan, routing...) // Audit of firewalls // Audit of copper/fiber connections // Audit of WIFI terminals // Creation of a file of recommendations with classification (importance, urgency, difficulty) // Installation of Meraki routers // Installation of new Aruba WIFI terminals // Creation and configuration of VLANs // Configure switch ports // IT support

Energy sector

Primary customer requirement: Drafting and analysis of an official technical document

Neywork responded to this customer by first offering to send him the documents in their possession.

Based on the documents and their analysis, a network and security audit was undertaken. A question-and-answer session was organized to refine the data in our possession.

Our team of experts produced an audit document and recommendations.

The customer validated the proposed recommendations.

We took over the drafting of the document, including a teleworking charter, a byod, an entry/exit sheet and awareness training.

Following on from the recommendations, we are making progress on configuring their core network with a cloud-based next gen solution, installing the necessary hardware (cabling and racks), helping them install a cloud proxy to secure all their workstations, regardless of where each user is working, and setting up a secure digital directory.

Energy sector

We worked with a fast-growing energy start-up. The company grew from 20 employees in the first year, to 300 after 2 years. We supported them in the creation of their IS infrastructure. Sizing, scalability and security were the watchwords of the support project. We put in place a number of measures, including a scalable, high-performance and secure local network, a physical hosting infrastructure that met the security requirements of the customer, and storage and backup systems to prevent any loss of data.

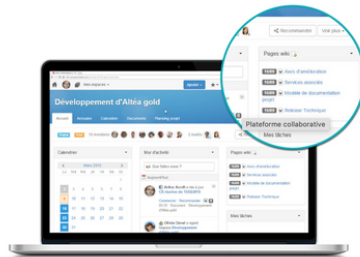
